SUMMARY

Final Offer Price and Net Proceeds

- The final Offer Price has been determined at HK\$0.145 per Offer Share (excluding brokerage fee of 1%, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the final Offer Price of HK\$0.145 per Offer Share and the 500,000,000 Shares offered by the Company, the net proceeds from the Share Offer to be received by the Company and after deducting the underwriting fees and commissions and estimated expenses payable by the Company in relation to the Share Offer is estimated to be approximately HK\$36.7 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Future Plans and Use of Proceeds” in the Prospectus. To the extent that the net proceeds from the Share Offer are not immediately used for such purposes and to the extent permitted by the relevant laws and regulations, the Company intends to deposit such net proceeds into interest bearing bank accounts with licensed banks or financial institutions.

Public Offer

- The Offer Shares initially offered under the Public Offer have been very significantly over-subscribed. A total of 18,566 valid applications have been received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms, through giving **electronic application instructions** to HKSCC via CCASS and through the designated **HK eIPO White Form** service for a total of 5,827,440,000 Public Offer Shares, representing approximately 116.55 times of the total number of 50,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the very significant over-subscription in the Public Offer Shares, the reallocation procedures as described in the section headed “Structure and Conditions of the Share Offer — Public Offer — Reallocation of the Offer Shares between the Public Offer and the Placing” in the Prospectus has been applied. As the number of Offer Shares validly applied for in the Public Offer represents 100 times or more of the number of Offer Shares initially available for subscription under the Public Offer, a total number of 200,000,000 Offer Shares have been reallocated from the Placing to the Public Offer. As a result of such reallocation, the final number of the Public Offer Shares is 250,000,000, representing 50% of the total number of the Offer Shares available under the Share Offer, and being allotted to 10,423 successful applicants under the Public Offer.

Placing

- The Offer Shares initially offered under the Placing have been moderately oversubscribed which are equivalent to approximately 1.33 times of the total number of 450,000,000 Placing Shares initially offered under the Placing. The final number of the Placing Shares allocated to 204 placees under the Placing is 250,000,000, representing 50% of the total number of the Offer Shares available under the Share Offer. A total of 194 placees have been allotted 100 board lots of Placing Shares or less, representing approximately 95.1% of the total number of placees under the Placing. A total of 175,000,000 Placing Shares have been allotted to these placees, representing 70.0% of the 250,000,000 Placing Shares after reallocation to the Public Offer. A total of 186 placees have been allotted 50 board lots of Placing Shares or less, representing approximately 91.2% of the total number of placees and approximately 63.6% of the 250,000,000 Placing Shares after reallocation to the Public Offer.
