PROFIT WARNING

This announcement is made by Dowway Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10 of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined under the GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board of directors of the Company (the “**Board**”) wishes to inform the shareholders of the Company (the “**Shareholders**”) and potential investors of the Company that, based a preliminary assessment of the financial performance of the Group for the year ended 31 December 2023 (“**FY2023**”) and the information currently available to the Board, the Group is expected to record:

- (1) a revenue dropped from approximately RMB177,132,000 for the year ended 31 December 2022 (“**FY2022**”) to approximately RMB117,446,000 for FY2023, which is primarily attributable to a decline in spending from businesses and individuals for these services, which had a cascading impact on the exhibition and event management sector and also driven by a decline in advertisement-related services during FY2023, as a result of the worldwide macroeconomic landscape following the COVID-19 pandemic and overall economic conditions and consumer behavior significantly changed in 2023, restricting people’s consumption ability; and
- (2) a net loss attributable to the owners of the Company of not less than RMB16,918,000 for FY2023 as compared to consolidated net loss attributable to the owners of the Company of approximately RMB36,454,000 for FY2022, which was primarily driven

by a significant decrease in revenue and the effect was partially offset by decrease in net allowance for expected credit loss on trade and other receivables and contract assets.

The Company is still in the process of finalising its consolidated financial statements for FY2023. The information contained in this announcement is only based on a preliminary assessment by the Board, with reference to the unaudited consolidated management accounts of the Group for FY2023 and other information currently available to the Board, which have not been confirmed, reviewed or finalised by the auditor of the Company or audit committee of the Company as the date of this announcement and may be subject to adjustments upon further review.

Further details of the Group's financial results and performance for FY2023 will be disclosed in the results announcement in accordance with the requirements of the GEM Listing Rules, which is expected to be published before the end of March 2024.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.
